Dear Neighbours,

I hope this Newsletter find you well,

I would like to thank all residents who attended the Meet the Contractor event at St Barnabas Church last month; it was great to meet so many of you. I hope you found the event useful and it gave you a good understanding of the upcoming Cundy Street Quarter works. I am pleased to announce that we have made the anticipated good progress with setting up our site office, welfare and with the perimeter hoarding construction to the boundary of the site. The hoarding will be completed on the external footpaths and Coleshill Flats no later than 21<sup>st</sup> December, leaving only the Walden House elevation which will commence January 2022.

I hope that you may have seen the green hoarding that has now been erected on Ebury Street. We are working with Biotecture to install greenery around the site to help improve biodiversity and air quality as well as providing a visually interesting streetscape. We look forward to seeing it blossom next year.

In the run-up to Christmas, we are going to perform ground investigations in the Coleshill Flats carpark. Once we have completed the excavation trench, we will fill and repair the surface with tarmac to bring it back to its original appearance. A heras fence exclusion zone will be used to exclude our works from the public.







## **John F Hunt**

We are fast approaching Christmas and will be closing the site on the 21<sup>st</sup> December for two weeks, returning on the Tuesday 04<sup>th</sup> January. We will maintain a 24hr/day security inside the site and our guards will also perform regular external inspections around the perimeter hoarding to ensure any potential issues are dealt with and relayed to the relevant parties immediately. Responsive lighting will also be installed to the hoarding to ensure footpaths are safely lit during the night.
