

Dear Neighbours,

I hope you are all well and have read Newsletter No6 which described the construction of the new Cross-Over in Pimlico Road, between 20th June and 27th June. We promised you would have a safe, segregated walkway along Pimlico Road at all times, the detail of which would be described in this Newsletter No7, so here it is:



Cross-Over 1 Location:



Methodology for Crossover 1 Installation:

- 1. CAT Scan Crossover 1 Area & Highlight Existing Services.
- 2. Crossover Works to be completed in 2 sections. This is to allow and maintain pedestrian access through out the works.
- 3. Barriers to be set up to demark work area 'Section 1' and maintain WCC minimum Footpath Pedestrian Access width of 1200mm.
- 4. Existing Paving Slabs/kerbs to be lifted, and stored securely on site. Build-up under slabs to be removed by using insulated tools. Excavated material to be bagged and stored on site prior to removal.
- 5. Type 1 Bed to be installed at required levels in preparation for Concrete Crossover.
- 6. Concrete to be placed at required levels to form Crossovers.
- 7. Process is repeated for 'Section 2' half of crossover, again maintaining Pedestrian Footpath access.
- 8. Bottom Timber Plinth on existing hoarding to be removed.
- 9. Repeat Steps 4, 5 & 6.
- 10. Hoarding Timber Plinth to be re-instated and hoarding cleaned and painted.
- 11. Crossover Works to commence 20th June 2022.
- 12. Works anticipated to take 1 Week to Complete.



We would like to thank you for your co-operation during these cross-over construction works. Please remember that if you have any queries or concerns, that we are available to have a face to face visit in our site office in Laxford House off of Cundy Street between 8am and 6pm daily.

We will ensure you have a clear unobstructed walkway on the Pimlico Road pavement at all times.
